Tax relief can be claimed in respect of health expenses paid by you on your own behalf or on behalf of another person.

**REMEMBER, WE CAN CLAIM BACK FOR THE LAST FOUR YEARS!**

## Prescriptions:

Medicines prescribed by your Doctor or Consultant. This can be quite costly if you are on a monthly prescription basis!

## Documentation Required:

Summarised Prescription Report from your Chemist(s).



Services of a **Doctor or Consultant, Treatment in a hospital (including X-rays)** and/or **transport by Ambulance.**

## Documentation Required:

Receipt from your Doctor and/or hospital.

## Dental Expenses:

Specialised dental work such as Crowns, Veneers, Root Canal, Braces, Bridgework or Surgical Extraction of Wisdom Teeth.

## Documentation Required:

**MED 2** Form completed by your Dentist.



## Maternity Care / IVF:

The cost of providing routine health care in respect of pregnancy and also the cost of providing IVF treatment.

## Documentation Required:

Receipt from Specialist.

## Physiotherapy or Similar Treatment

On referral from a Doctor

## Documentation Required:

Receipt from qualifying Practitioner

## Caring for a dependent:

Do you have a child who requires ongoing care/attention as a result of a disability?  
If yes, you may be eligible to apply for the Incapacitated Child Tax Credit.

- Coeliacs or Diabetics (Report available from supermarkets via Loyalty Cards)
- Medical appliances

- Orthopaedic expenses
- Speech and Language Therapy
- Educational Psychological Assessment
